Q&A WITH TESSA

Where are you from?

I come from Pinaymootang First Nation in Manitoba, Canada, I am Anishinaabe (Ojibwe). I have spent much of my life In Denver, Colorado, where I reside.

What are you passionate about?

I am passionate about increasing and sharing minobimaadiziwin, an Ojibwe philosophy which translates to the 'good life' in English. The good life is so simple and so complex at the same time; I translate it to having gratitude, generosity and humility. If we appreciate a cup of coffee to drink this means we have a cup, coffee, water, senses to enjoy it, and a belly to fill... this is the good life. Through a different lens, if we have energy in our homes to heat our bones and cook our food, well that is the good life too. If we don't have access to simple things like energy, let's work on sharing the good life. As a political scientist, I also believe in increasing self-determination of Indigenous peoples and communities. I think much of my work experience has enabled me to work in increasing self-determination of our communities in different aspects such as through planning, supporting local indigenous food systems, and by advocating for Indigenous Rights. I am also passionate about sharing my voice for issues such as the Missing and Murdered Indigenous Peoples crisis through advocacy and teaching.

What attracted you to SEE Renewal?

Many things! First, I have been fortunate to know Amy Wilson for several years now, thanks to our previous work together under the Office of Indian Energy and Economic Development. Amy has been a role model for me, she works hard, she is committed to giving her best, she enjoys working in Indian Country, she thinks outside of the box; I am glad to work with Amy again at SEE Renewal. Second, for me, it is important to work for a company that is rooted in values such as Respect, Honesty, and Expertise, which are foundational values for SEE Renewal.
